## A COST SAVING OF 42%

We ran a 'Compete' exercise for De Lijn, with impressive results. We compared the

existing situation in which De Lijn uses a lot of Oracle databases with a switch to comparable SQL Server technology. De Lijn could save up to 42% over a period of five years, even including the cost of the migration, licences and applications. By migrating to SQL Server, De Lijn could almost halve their costs compared to working in the Oracle environment. So it's no surprise that De Lijn decided to switch to SQL Server.

## LOWER LICENCE FEES

At the CHU Tivoli Academic Hospital in La Louvière, we compared the Sybase environment with a switch to SQL Server. We looked at what we could transfer easily, what manual work was required, and what code we would have to update.

This gave the hospital a good estimate of the expected time and costs. We can certainly reduce the number of servers and maintain the same performance at CHU Tivoli, and so reduce the cost of licence fees.

## ADVICE FOR A COST-EFFICIENT ENVIRONMENT
